SUMMARY OF PROCEEDINGS OF THE 67th ANNUAL GENERAL MEETING

The 67th Annual General Meeting ("AGM") of the Company was duly convened and held on Friday, August 9, 2024, which commenced at 04:30 P.M (IST) and concluded at 04.56 P.M. (IST) through Video Conferencing (VC)/ Other Audio Visual Means (OAVM) in accordance with the applicable provisions under the Companies Act, 2013 ['Act']; SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 ['SEBI (LODR)'] and Relevant Circulars issued by Ministry of Corporate Affairs ['MCA Circulars'], Circulars issued by Securities Exchange Board of India ['SEBI Circulars']. The proceedings of the AGM were deemed to be conducted at the registered office of the Company i.e. 9 Parsee Church Street, Kolkata – 700 001 which was the deemed venue of the AGM.

Proceedings in Brief

- ➤ Ms. Komal Dhruv, Company Secretary, welcomed all the Members attending the AGM and briefed the Members about the general guidelines to be followed during the Meeting and informed that the AGM was conducted through VC / OAVM.
- > The Company Secretary thereafter informed the following points:
 - a. The Company had engaged the services of Central Depository Services (India) Limited (CDSL) to provide remote e-voting facility which commenced on August 6, 2024 at 9 A.M. and ended on August 8, 2024 at 5 P.M. and e-voting facility during the AGM to all the eligible Members to enable them to cast their votes electronically in respect of the businesses transacted at the Meeting.
 - **b.** The facility for voting at the Meeting through e-Voting System provided by Central Depository Services (India) Limited was made available to Members who had not cast their vote by remote e-Voting prior to the Meeting and were attending the Meeting.
 - **c.** The Statutory Registers as maintained under Companies Act, 2013 along with other relevant documents as required, were kept accessible electronically during the continuance of the Meeting.
- ➤ She further introduced the Directors & Senior Executives, who joined the Meeting. All the Directors including the Chairperson of the Stakeholders Relationship Committee and Nomination and Remuneration Committee and authorized members of Audit Committee were present at the AGM. Representatives of the Statutory Auditors and Secretarial Auditors

of the Company and Mr. Atul Kumar Labh, Scrutinizer were also present at the Meeting from their respective locations.

- Total 49 Members attended the AGM as per the records of the attendance.
- ➤ The Company Secretary informed that Mr. Sudeep Chitlangia chaired the meeting. The Chairman after ascertaining that the requisite quorum was present declared that the Meeting was validly constituted and commenced the proceedings of the Meeting.
- ➤ The Chairman then delivered his speech to the Shareholders covering the highlights on the industry overview, future outlook and performance of the Company during the year 2023-24 and thereafter with the consent of the Shareholders present, took the Notice and the Annual Report for the financial year 2023-2024 comprising of the Audited Financial Statements and Director's Report, as read.
- ➤ He further stated that the Statutory Auditor's Report & Secretarial Auditor's Report does not contain any qualifications, reservation, adverse remarks or disclaimer. Hence, Reports are not required to be read out, as provided in the Companies Act, 2013. However, with the consent of the Members took them as read. Thereafter the Chairman requested the Company Secretary to brief the Agenda of this AGM to Members.
